

Purpose of Training

- The CCS training programme is designed to equip pharmacists with essential skills under the Common Conditions Scheme. Standardised approach.
- Under S.I. No. 507/2025 Pharmaceutical Society of Ireland (Education and Training required to prescribe medicinal products in accordance with a Common Conditions Service) Rules 2025 completion of this eLearning is a **regulatory requirement** for anyone wishing to provide the Common Conditions Service.

Multidisciplinary Collaboration

- Pharmacists, GPs, patients, clinical advisors, eLearning designers, and regulatory experts
 collaborated closely to develop the programme.
- Evidence-based content, practical, accessible and engaging for learners.





Programme Overview

Programme Structure

The programme includes one core module and eight condition-specific modules. Set up as two courses on IIOP Platform.

- Core Module
- The core module provides essential legal and ethical considerations, as well as prescribing competence, guidance on documentation, communication and AMS.
- Four-Step Module Structure Conditions
- Modules follow a consistent four-step approach: patient assessment, checking protocols, treatment options, and special considerations.

Interactive Learning

Modules use videos, case scenarios, knowledge and reflection checkpoints and assessments.



Completion and Certification

Successful completion involves MCQ. Two certificates required for service provision.
