- National Engagement on Digital Health & Social Care – Findings
- HIQA, in partnership with the Department of Health and the Health Service Executive, conducted the National Engagement on Digital Health and Social Care to understand the attitudes of the Irish public and professionals regarding the digitalisation of health and social care services.
- The engagement involved a survey with 2,009 members of the public, a survey with 1,020 professionals and focus groups.
- We found that the Irish public and professionals are ready to embrace digital technologies in healthcare.

- Healthdata@IE National project to support the implementation of the European Health Data Space An EU grant-funded project being delivered in collaboration between the Department of Health, HIQA and the Health Research Board (HRB).
